**Re: Probationer/Parolee Erminio Gonzalez Arrested**

March 26, 2012

New Mexico Corrections Department probationer and parolee Erminio Gonzalez (#63953) is charged with leaving the scene of an accident resulting in death/failure to render aid. Gonzalez was arrested Saturday, March 24, 2012, by the Albuquerque Police Department. Gonzalez is being held at the Metropolitan Detention Center for the new charges and pending a revocation hearing. Probation and Parole officers will be conducting an assessment to provide a recommendation to be considered by the court for sentencing.

Since Gonzalez' January 13, 2012 prison release, Gonzalez has completed 20 office visits. A Probation and Parole Officer also made 6 field visits to Gonzalez. Gonzalez has had two drug tests and both came back negative but offender Gonzalez admitted to using heroin. Probation and Parole referred Gonzalez for appropriate services.
