Re: Probationer Ria Edenfield Arrested

Probationer Ria Edenfield (DOB 09/22/1984) is at the Metropolitan Detention Center charged with Abuse/Endanger Childs live/health, Conspiracy to Commit 3rd or 4th Degree Felony, Distribute/Sale/Barter/ Give Controlled Substance, and Possession of Methamphetamines.

On December 6, 2011 Edenfield lit up the pipes for Rachel Head to smoke Methamphetamines while Head's toddler was present. This incident was video recorded. When investigators discovered Edenfield as the participant in the video, a warrant was issued for her.

Edenfield was called to the Albuquerque Probation and Parole office on Wednesday (5/23/12). Probation and Parole Officers took her into custody and transported Edenfield to MDC for the new charges.

Edenfield was put on probation 10/07/11 for Shoplifting and Criminal Trespass, both are misdemeanor convictions. Her probation was revoked on 01/31/2012 for failing to report as instructed and testing positive for methamphetamine. Her probation was reinstated on 02/21/12. Edenfield had two disciplinary issues since then: (1) leaving the county without permission and (2) failing to follow rules of a mandatory program.
