Re: Probationer Arrested in Sandoval County

Probationer Richard Raymond Padilla (DOB: 11/29/1991) is detained at the Sandoval County Detention Center pending a Probation Violation Hearing. He was arrested in Sandoval County June 2, 2012, by the Bernalillo Police Department. Probationer Padilla was charged with Aggravated Assault on a House Hold Member and Negligent Use of a Deadly Weapon. A .22 caliber rifle was found in Padilla's vehicle and when tested his BAC was recorded at .18. Padilla also did not have permission by the Espanola Probation and Parole Office to be outside of Rio Arriba County.

Padilla has had several probation violations while under supervision. On March 26, 2012, Padilla was arrested by Probation and Parole Officers for drinking alcohol and smoking Marijuana. He was given a 72-hour sanction and paneled into Community Corrections in Rio Arriba.

On April 11, 2012 Padilla was arrested by Espanola Police Department for new charges of a Felon in Possession of a Firearm and Negligent use of a Weapon. He was under the influence of alcohol at the time of the incident. Probationer Padilla was arrested and transported to Santa Fe Detention Center.

On May 18, 2012 Probationer Padilla was released from custody by the Court to report to probation and continue participating in Community Corrections.

Prior history : On November 21, 2011, Padilla was given a Deferred Sentence and placed on supervised probation for (3) three years for charges of Possession of Burglary Tools, a fourth degree felony offense and Receiving Stolen Property, a fourth degree felony offense.
