Re: Three Probation/Parolees Arrested in Conjunction with Santa Fe Property Crime Sweep

New Mexico Corrections Department Probation and Parole officers in Santa Fe assisted the Santa Fe Sheriff's Office and the United States Marshal Service, in a local unified effort to crack down on property crime offenders in the Santa Fe area. During the blitz, our law enforcement partners arrested three NMCD probation/parolees. The three offenders were arrested after failing to comply with their conditions of probation/parole, and are being held at the Santa Fe County Adult Detention Center.
