A successful saturation effort by New Mexico Corrections Department Probation / Parole, Albuquerque Police Department (SE Impact), New Mexico Department of Corrections Security Threat Intelligence Unit, along with the United States Marshals Service was conducted in the Albuquerque area Friday September 7, 2012.

Nine arrest and holds were issued for probation violations and one warrant being cleared (see list below). 3 Offenders picked up new felony charges and 1 offender was so intoxicated he had to be transported to the Bernalillo County MATS Detox Program.

A total of 130 home visits were conducted. This was the fifth year for the South East Summer Nights Operation.

Information gathered from this operation consisted of offender reporting addresses that did not exist, offenders not reporting other offenders living with them, offenders living with felons or other individuals that could be detrimental to their supervision. Other situations consisted of knocking on the offender’s door and finding alcohol, spice, drug paraphernalia and/or controlled substances.
