
DEFINITIONS:

- A. Video conference: Video system which allows two or more sites to communicate by two-way audio and video transmission.

- B. Conference number: A unique access number assigned to a video conference controller which connects multiple video units together to establish a conference session.
- C. Conference Recorded: A video with audio recording of the entire conference including all video endpoints which participated. Can be provided on a DVD, CD, or watched later via streaming media (online viewing to a PC through the network).

A. Request Submission


1. Complete the **Video Schedule Request** form (*CD-044101.1*) and send via email to: NMCD-video@state.nm.us. Due to high demand for video services and conference rooms, early scheduling is encouraged.
 - a. For internal agency video conferences, please submit form (*CD-044101.1*) two (2) weeks prior to requested conference date, if possible.
 - b. For outside agency video connections (e.g. SPO, JID, NMCOURTS, Contractor, etc.) please submit form (*CD-044101.1*) a minimum of three (3) weeks in advance of the requested conference date, if possible.

B. Request Processing

1. Upon receipt of the **Video Schedule Request** form (*CD-044101.1*), ITD will verify availability and the requested conference will be placed on a video conferencing calendar and assign a conference number.
2. ITD will send a confirmation of the conference schedule(s) and conference number(s) to the requestors via email.
3. Requestors are responsible for scheduling meeting rooms, staff, etc., and sending notification of the conference number via email to all participants prior to conference start time.
4. The current video conferencing calendar is available in the **email** system for users to view for tentative planning purposes. It is Located inside the Public Folder, under "Departments" folder, inside the "New Mexico Corrections Department" folder and inside the "Information Technology Division" folder is the calendar. *See attachment (CD 044101.B) as an example of the calendar.*

C. Conferences

1. ITD recommends all video conference participants connect to the conference a minimum of fifteen (15) minutes before the conference is to start. In the event a technical problem arises, fifteen (15) minutes will allow ITD time to remedy most video issues.

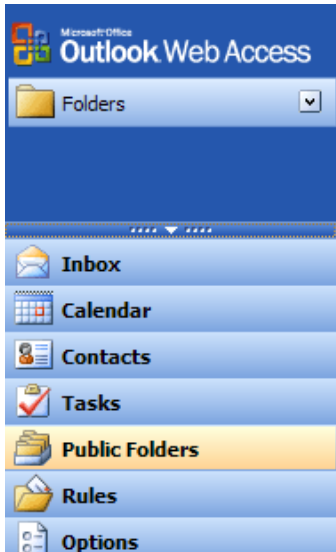

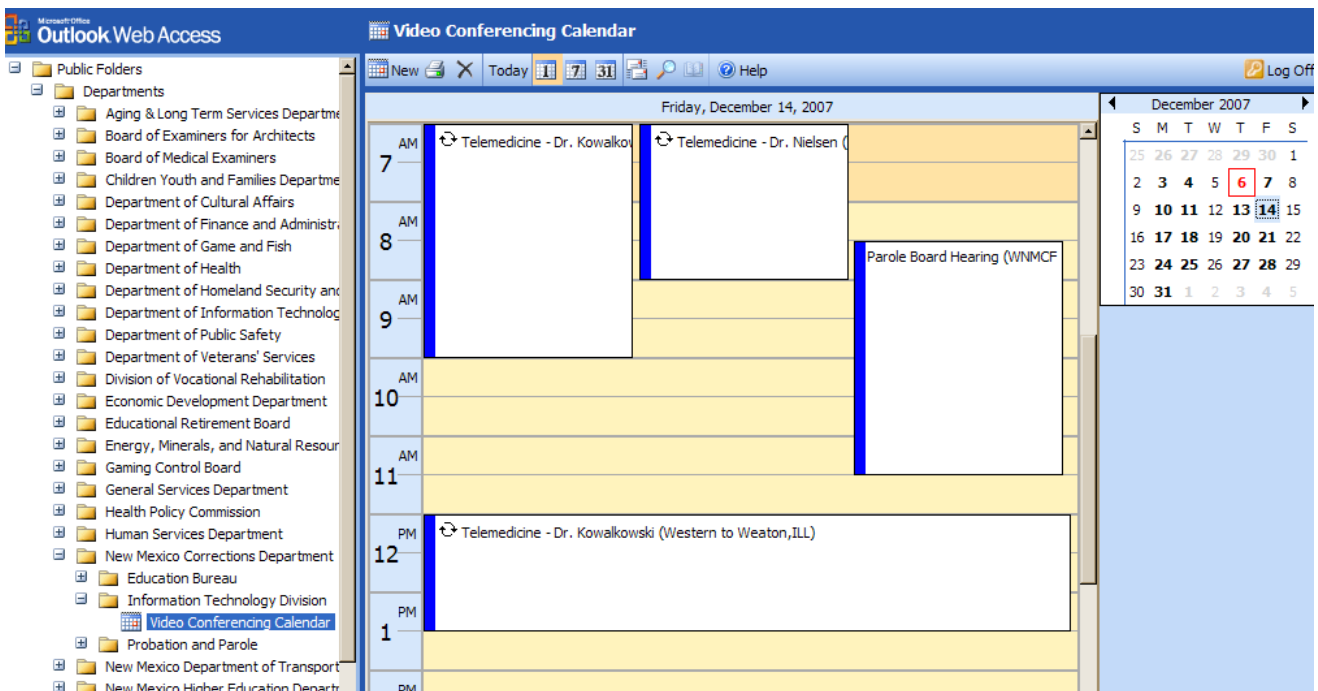

Gallup PPO, Las Cruces PPO, Gold PPO, Las Vegas PPO, Bernalillo PPO

Central Office Administration Complex

Video conferences between any of these sites are available five (5) days a week normal hours and multiple concurrent conferences.

Also Video conferences with outside business partners on the Internet or other state agencies are available five (5) days a week normal hours to these sites

Sites not listed above are connected via lower speed 1.5Mb data circuits and are limited in availability. No concurrent conferences allowed.
