## Northeastern New Mexico Detention Facility

### Initial Volunteer Training for New Volunteers Only:

All new volunteers and/or volunteers who have not attended a face-to-face volunteer training prior to December 31, 2018, you **must complete an initial volunteer application and submit it at least fourteen (14) days prior to the training date for processing and approval.** Only those volunteers who have been approved can attend the training and receive an ID card/badge. Additionally, you must have received either an email or phone call from Chaplain Mark Honeycutt to attend the below trainings.

Additionally, renewal Volunteer ID cards will only be issued for volunteers whose current ID card was lost, expired, and/or you were never issued one.
